Division News: The Latest from the Division of Licensing

Legislative Updates

On July 1, 2024, Senate Bill 1084 became law. Senate Bill 1084 made the following changes to Chapter 493, Florida Statutes:

It amends Section 493.6113(3)(b), F.S., to allow a Class "G" licensee to qualify for up to two calibers of firearms in one 4-hour firearm requalification class if the licensee successfully completes training for each firearm, including a separate course of fire for each caliber of firearm. This will not be required and is at the discretion of the Class "K" Firearms Instructor. There will be no change to the process for Class "G" applicants and licensees to submit training records to the department.

It adds Section 493.6127, F.S., to allow the department to appoint tax collectors to accept new, renewal, and replacement Chapter 493 license applications on behalf of the department. The law will also allow tax collectors to provide stand-alone fingerprint and stand-alone photo services for people applying either online or by mail. A tax collector appointed to accept applications on behalf of the department will be statutorily authorized to collect convenience fees for each transaction (\$22 for new applications, \$12 for renewal or replacement applications, and \$9 for stand-alone photo or stand-alone fingerprint services). The department began partnering with tax collectors in 2014 to accept concealed weapon or firearm license applications. To date, fifty-six counties have partnered with the department to provide concealed weapon or firearm license applications, and many counties have already expressed interest in providing Chapter 493 license services. The department will post a Notice of Rule Development in the Florida Administrative Register to specify types of Chapter 493 applications tax collectors will accept.
