188 **EXECUTIVE DIRECTOR'S REPORT – CHRISTOPHER GREEN**

190 Mr. Green reported the following:

- 191

 - There are 2,423 active LS surveying licenses
 - There are 73 delinquent LS surveying licenses
 - There are 1, 103 active LB surveying licenses
 - There are 27 delinquent LB surveying licenses. All have been contacted and have not responded to the e-mail request.
 - Each LB has been reviewed to determine if the Surveyor of Record is an officer of the corporation, required by statute and rule.

- There are currently 121 active LB licenses that are issued to business that are not compliant. All have been contacted and have been strongly urged to become compliant.
- The 2026 Florida Legislative Session ended on March 13, 2026. The legislature reconvened this week in special session to complete work on other priorities including the Florida budget.
- There were no bills passed this legislative session which directly impact PSAM. He stated that HB927 passed. He said that this bill affects Chapter 177, however, it doesn't fall under the jurisdiction of PSAM. He said that the main change is that each county with 75,000 or more residents and each municipality with 10,000 or more residents to create and implement a program for the purpose of making development pre-application consultation services available at an applicant's request. The legislation authorizes the county or municipality to use a qualified contractor or qualified contractor firm to fulfill specified pre-application services requirements. He stated that surveyors and mappers or a surveying and mapping firm may fall under the definition of qualified contractor or qualified contractor firm.
- 2026 NCEES Southern Zone Meeting –Don Pedigo, PLS, was elected as the NCEES Southern Zone Secretary. The NCEES President, Elizabeth Beckett-Johnston, P.E., encouraged all members of NCEES to review the committee assignments. He stated that there is a survey at www.NCESS.org to select if you are interested in becoming a NCEES committee or taskforce member for the upcoming year. (This survey closed at the end of the day on April 30, 2026). He stated that there were 15 NCEES committees and taskforces that provided reports. As a result of the work of the committees and taskforces, there will be 93 motions on the agenda for the NCEES Annual meeting scheduled for August 2026. All motions will be available at www.NCEES.org in July 2027. He stated he attended the Member Board Administrator (MBA) forum and the hot topic for MBAs in the Southern Zone was fraudulent signatures and seals for both engineers and surveyors and seems to be a problem across all jurisdictions. He stated that he is working with the PSAM prosecutor on possible situations to investigate and act. He stated that there is a website called, "FIBERR". This website is an online marketplace that connects businesses and individuals with freelancers offering a wide range of services. He stated that there are scammers that are using this website to impersonate licensed engineers and surveyors, and then they are selling a product that is either invalid or taking the money and not providing services. NCEES is looking into this and may create a taskforce to address this problem. He stated that the Southern Zone members unanimously supported PSAM Board Member, Ia Hall, as a nominee for NCEES Treasurer. He said that the 2027 Southern Zone Meeting will be held April 22-24, 2027, in Omaha, Nebraska, and will be an all-zones meeting.
- The NCEES 2027 Annual Conference will be held August 18-21, 2027, in Henderson, Nevada. Every member of the Board is invited to attend this meeting.
